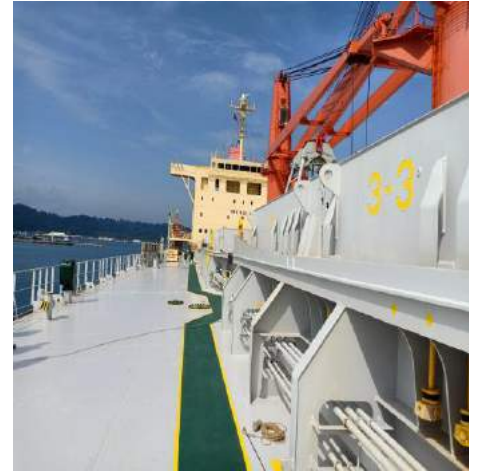

# BUREAU OF CUSTOMS ACCREDITED SURVEYOR FOR BULK AND BREAK BULK PROGRAM



Control Union Philippines, Inc. is an accredited surveyor by the Philippine Bureau of Customs to issue Load Port Survey Reports (LPSR) for bulk and break bulk cargoes. The main purpose of cargo surveying is to verify the quantity and quality of the shipment based on the specifications agreed upon between the buyer and the seller. Surveying confirms contractual requirements and provides support for the final settlement of the process. Shipments that are inspected at the load port by an accredited cargo surveyor such as Control Union, shall prima facie be deemed to have been examined for customs purposes and shall no longer be re-examined upon arrival in the country but shall instead be immediately released.

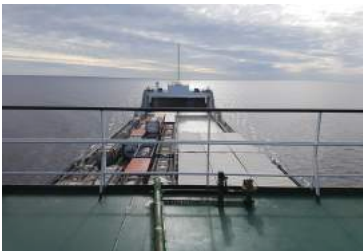

Inventory of Hazardous Material (IHM) is a document identifying all potentially hazardous materials onboard a vessel. Hidden hazards are identified, located, and quantifies following IMO Resolution guidelines. This will help ship owners maintain control of hazardous materials by detailing the types, quantities, and locations of such materials onboard each vessel. The presence of the inventory will then ensure the safety of crew members during the vessel's working life, and also the safety of workers during the recycling process.
